
sure that our associations can grow with stable membership and we can all help by encouraging all dentists to be members of the tripartite.

BOARD OF TRUSTEES REPORT



Friends and colleagues,

It is hard to believe that 2023 has just about come to a close. I hope that 2023 has been a good year for everyone and that this holiday season is joyous.

I am writing you this update upon returning from our most recent Board of Trustees (BOT) meeting. Our December meeting was held at the FDA headquarters in Tallahassee. The FDA Foundation (FDAF) board had its annual in-person meeting just before the BOT meeting and there was a chance for interaction between both groups.

Speaking of the Foundation, this important non-profit portion of your FDA supports many worthy endeavors. Just recently, FDAF supported Project: *Dentists Care* with a \$50,000 donation to help with their mission to provide care for those most in need. Support also goes out when dentists in Florida are affected by hurricanes. The flagship event is the *Florida Mission of Mercy (FLA-MOM)*, which will be held May 30-June 1, 2024, in Lakeland. Please sign up to volunteer at flamom.org and consider donating to the Foundation to support all their fantastic work.

The BOT received an update on our media campaigns' efforts to raise public awareness about the importance of routine dental care, reinforcing the authority of the FDA as the reliable source for oral health information and directing patients to seek care from FDA member dentists. From December 2022 through November 2023, this campaign has resulted in over 22,000 clicks on the Find a Dentist page that the ADA manages.

As usual, our Governmental Affairs team has been working very hard getting ready for the upcoming session in Tallahassee. One of the biggest strengths of organized dentistry lies in the tireless advocacy on our behalf, which ensures that our profession and the patients we serve are protected. This legislative session will have a focus on health care. We are monitoring any potential legislation that will be introduced and will work to support positions that benefit dentistry. We are also pushing hard for much-needed insurance reforms and patient protections in response to the rise in direct-to-consumer dentistry and advocating for \$500,000 in funding for the 2025 *FLA-MOM*. Our voices must be heard loud and clear in Tallahassee this session. Please plan on attending *Dentists' Day on the Hill* on Jan. 30, 2024. There will be a legislative briefing and dinner the night before.

The BOT will meet on March 20, 2024, via Zoom and in person on May 17-18, 2024 at FDA Headquarters in Tallahassee. Please do not hesitate to contact me at tbrown@bot.floridadental.org with any concerns.


RECENTLY RETIRED OR RETIRING SOON?

Most retired members pay little or no dues to maintain their membership and keep access to all their benefits and services.



RECEIVING EMERGENCY DENTAL CARE OVER THE HOLIDAYS-

With the holidays here, we wanted to remind you that you are required, either personally, through another Florida-licensed dentist or through a reciprocal agreement with another group, to provide 24-hour emergency care for all patients under your continuing care. If you do not provide this emergency care, then you are subject to discipline by the Board of Dentistry (BOD). Emergency care is also listed in the ADA's Dental Patient Rights and Responsibilities Statement. It states that a patient has the right to reasonable dental care and emergency treatment arrangements. The full list of patient's rights and responsibilities can be found at ada.org.



The BOD Rule on this is 64B5-17.004, Emergency Care: It is the responsibility of every dentist practicing in this State to provide, either personally, through another licensed dentist, or through a reciprocal agreement with another agency, reasonable twenty-four (24) hour emergency services for all patients under his continuing care.



REMINDER: RENEW YOUR DENTAL LICENSE BY FEBRUARY 28, 2024-



All Florida licensed dentists must renew their licenses through the MQA Online Services Portal for the 2022-2024 biennium by Feb. 28, 2024. You must have 30 hours of continuing education (CE) by the biennium deadline to renew your license by Feb. 28, 2024. Click here to view the list of courses you must take to renew. If you already have the required CE credits to renew your license, click here to start the renewal process.

Dental offices face fines and stop work orders due to a lack of Workers' Compensation! Member offices have reported being visited by audit personnel from the Florida OIR in the last few weeks. Some were found not in compliance with Florida law, mandating coverage for practices with four or more employees. FLORIDA DENTISTS HONOR AMERICA'S VETERANS

American professional sporting events these days often set aside a moment to recognize Veterans with a quick "thank you for your service" tribute. As heartfelt as the patriotic sentiment may be, this is only a first step in appropriately expressing gratitude to the men and women who have sacrificed so much by raising their right hands and taking an oath to protect our nation in uniformed services.

A major public misconception exists that the Veterans Administration Medical Centers (VAMC) provides for the health care needs of America's Veterans. In reality, access to VA care is available based on disability rating. To receive dental care, Veterans must be 100% disabled or former prisoners of war. Only 9% of Veterans meet this criteria as defined in U.S. law and even less, approximately 3%, are receiving dental care.

To directly serve local Veterans, Pasco County Dental Association (PCDA) member dentists and FDA members from around the state have participated in Stars, Stripes, and Smiles, a single-day annual event providing relief from pain, infection and embarrassment from untreated dental disease — at no cost to the patient.

Each year since 2015, approximately 70 Veterans have received examinations, radiography, oral hygiene instructions, fillings, dental cleanings, extractions, root canal therapy and denture services from doctors, dental hygiene students and dental assisting students attending the Pasco Hernando State College (PHSC).


One Veteran who received care, Ken, had been trying over the last few years to have the remaining teeth in his mouth removed so that he could finally obtain a denture so that he could digest his meals better and perhaps have the confidence to obtain employment.

The collaboration between the PCDA, the office of Congressman Gus Bilirakis, and the PHSC directly met the urgent needs of the patients, but the patients still need a dental home.

The annual event has also raised awareness about Veteran dental care needs and legislation, <u>HR 2410 – VETCARE Act of 2023</u>, introduced by Congressman Bilirakis and co-sponsored by all of our dentist members of Congress. This bill would create a pilot program in five VA centers to help America's Veterans live healthier lives through improved oral health while saving Veterans and all taxpayers money.

A REQUEST FOR INSIGHTS ON DISRUPTIVE PATIENT BEHAVIORS-

A new research project, led by University of Florida (UF) behavioral scientists and dental school faculty, asks dental professionals and students to complete a brief survey regarding their views about patients' disruptive behaviors during dental appointments. Specifically, the survey will ask about the types of training dental professionals have had in addressing disruptive behaviors during appointments, what responses to disruptive behaviors are most common, and which of several behavioral intervention strategies for minimizing disruptive behavior (described in the survey) are considered practical or acceptable. The UF Institutional Review Board has approved this survey. The survey results will guide efforts to develop and evaluate practical interventions for helping reluctant patients, especially children and individuals with neurodevelopmental disorders, to tolerate routine dental examinations.

Any dental professional or dental student with experience delivering services to patients and currently resides in the U.S. is eligible to participate. Experience with patients who are disruptive or diagnosed with a neurodevelopmental disorder is not required. The survey will take roughly 10 minutes to complete and is entirely anonymous. 


