#### DR. ANDY BROWN NAMED ADA TRUSTEE-ELECT-



Florida Dental Association (FDA) Past President Dr. **Andy Brown** will represent the 17<sup>th</sup> District as a member of the American Dental Association (ADA) Board of Trustees (BOT).

Members of the 17<sup>th</sup> District delegation elected Dr. Brown at their January meeting and the FDA House of Delegates (HOD) unanimously ratified his election on January 20. He is currently an ADA trustee-elect and will be installed as a trustee in October.

The ADA BOT is the managing body of the association; its voting members consist of 17 trustees (one from each trustee district), the president-elect, two vice presidents and the new dentist committee chair. The president, treasurer and executive director are non-voting members of the board

which is responsible for the ADA's success and growth.

An orthodontist practicing in Orange Park since 1984, Dr. Brown has been actively involved with organized dentistry throughout his career. He is a past member of the FDA's BOT, a member of the Governmental Action Committee (former chair), and a liaison for the Council on Dental Health. He previously served the ADA as a delegate and vice chairman of the Council on Dental Practice. Dr. Brown is also past president of the CCDS and previously ran the Peer Review program for the NEDDA for nearly three decades.

While many of the ADA's districts are comprised of multiple states, Florida is its own district — the 17<sup>th</sup> Trustee District — in the ADA governing structure. Dr. **Rudolph "Rudy" Liddell** currently serves as the 17<sup>th</sup> District's trustee.



#### BENEFICIAL OWNERSHIP INTEREST REPORTING REQUIREMENTS FOR DENTISTS

Effective Jan. 1, 2024, a new federal law, the Corporate Transparency Act (*the "Act"*), requires most companies to identify all of their owners, beneficial and direct and/or officers to federal regulators. The scope of the Act is broad and will require providing a passport or state-issued ID for all individuals who own or control a company within the scope of the Act. Entities formed after Jan. 1, 2024, will have 90 days after formation to file the Beneficial Ownership Form. Existing entities will have until Jan. 1, 2025, to file the initial Beneficial Ownership Form.

Any corporation, LLC, partnership, or other entity created by filing with a Secretary of State must file a Beneficial Ownership Information Report (BOI) with the Department of Treasury's Financial Crimes Enforcement Network (FinCEN). The Act includes small businesses and single-purpose entities that merely hold assets and may include foreign entities. There are exemptions from the Act filing requirements primarily for entities already subject to substantial federal or state regulation, financial institutions, insurance companies, accounting firms and tax-exempt entities.

The first filings will be required beginning March 1 and penalties for failing to file can be significant. Civil penalties of up to \$500 per day can be imposed. Certain violations include criminal penalties. To view the BOI video, click <a href="here">here</a>.

#### ADA SENDS ISSUE ALERT ON RECENT FRAUD ATTEMPTS-


The ADA recently sent out an alert to members about recent fraudulent attempts to solicit information from individuals and entities who may be subject to reporting requirements under the Corporate Transparency Act — designed to mitigate the number of money-laundering operations posing as businesses. This act requires certain businesses, including dental practices, to report information to the U.S. Department of the Treasury's Financial Crimes Enforcement Network about their ownership.

However, as the Financial Crimes Enforcement Network began accepting beneficial ownership information reports Jan. 1, they were also notified of potential scammers sending messages that ask the



recipient to click on a URL or scan a QR code. These messages may be titled "Important Compliance Notice." If you receive an email as such, you are urged to not respond or click on any links or scan any QR codes within them.
